





1. Rahul International School, Survey No. 274+275/2/A/2 (Amenity Space), at Village Hinjewadi, Taluka Mulshi, Dist. Pune from academic year 2021-22 by Saumya Education Trust, Thane under the Maharashtra Self-Funding Schools (Establishment and Regulation) Act, 2012 (Primary to Higher Secondary, std. 1st to 12th, English Medium, CBSE, All Branches) was submitted for approval to start a new school on self-financing basis.

2. With regard to your application on the subject mentioned above, you are hereby informed that under the Maharashtra Self-Financed Schools (Establishment and Regulation) Act, 2012 and the Maharashtra Self-Financed Schools (Establishment and Regulation) Rules, 2020, Saumya Education Trust from the academic year 2021-22, Thane Operated Rahul International School, Survey No. 274+275/2/A/2 (Amenity Space), at Village Hinjewadi, Taluka Mulshi, Dist. Pune letter of intent to start work of school with following terms and conditions for approval of new school on self-finance basis (primary to high secondary Std. 1st to 12th, English medium, CBSE, all branch) is being given.





3. TERMS AND CONDITIONS:

(i) The said letter of intent does not guarantee a letter of approval unless the provisions of the Act and the rules made there under are complied with.

(ii) On the basis of the said letter of intent, the registered institution or trust or company shall not start schools / up gradation classes.

(iii) The said Letter of Intent, C.B.S.E. / I.C.S.E. / I.G.C.S.E. / I.B., etc. cannot be used as a non-revocation certificate for affiliation of boards.

(iv) That within 18 months from the receipt of the letter of intent by the registered organization or trust or company, as prescribed in the Right of Children to Free and Compulsory Education Act, 2009 and the Maharashtra Right to Free and Compulsory Education of Children Rules, 2011 and the directions issued by the Government from time to time under the Act and the Rules; compliance with standards, terms and conditions regarding infrastructure and physical facilities (such as classrooms, toilets, drinking water facilities, principal






and staff classrooms, libraries, laboratories, etc.) will be mandatory.

(v) After complying with the above mentioned facilities, it shall be the responsibility of the institution or trust or company to submit an application for letter of recognition to the area level authority of the concerned district within 18 months of receipt of letter of intent.

(vi) If within 18 months, the school management fails to submit an application for a letter of recognition, the letter of intent shall stand cancelled. The period of Letter of Intent cannot be extended under any circumstances.

(vii) After the letter of intent has been issued, the location of the proposed school cannot be changed. If the management applies for a letter of approval from a place other than the one approved by the government, the letter of intent will stand cancelled.

(viii) The State Government may cancel the letter of intent at any time on the ground of breach of any of the provisions of this Act or the rules made there under or failure to comply with any directions issued under the Act or standards or





standards or terms and conditions specified by the Government from time to time.

(ix) The said institution or trust or company shall be required to deposit the amount specified in "Schedule C" of the Act jointly in favor of the management and the concerned educational authority (secondary), in the form of National Savings Certificate or in the form of fixed deposit in any nationalized bank.




