WHEREAS the Settler is desirous of irrevocably settling a sum of Rs. 5,000/-(Rupees Five Thousand only) upon Trust for the public charitable purposes as hereinafter expressed or contained in these presents and in pursuance of such desire he has handed over prior to the execution of these presents the sum of Rs. 5,000/- (Rupees Five Thousand only) to the Trustees to be held as the Corpus of the Trust.

WHEREAS it is the desire and belief of the Settler that the corpus of the Trust may be further augmented from time to time by the flow of funds and other assets by way of the gifts or donations.

## **NOW THIS INDENTURE WITNESSES AS FOLLOWS:**

#### 1. NAME OF THE TRUST



That the Trust shall be known "SAUMYA EDUCATION TRUST"

## OFFICE OF THE TRUST

That the Office of the Trust shall be at : GROUND FLOOR- OFFICE MOTHER MARRYS JR COLLAGE, KASTURI PARK, NAVGHAR ROAD, BHAYANDAR (E) DIST- THANE 401 105 (INDIA), or at such other place/places in India as the Trustees may think fit from time to time.

- 3. That the Trustees shall hold the said sum of Rs. 5,000/- (Rupees Five Thousand only) plus the gifts, donations and subscriptions as they may receive from time to time from its members and public and all the incomes, profits and accretions thereto and the investments from time to time made out of the Trust funds in favour of Trust upon the powers and provisions as declared in these presents.
- 4. On execution of this Deed, the Trustees shall take charge of the said a sum of Rs. 5,000/- (Rupees Five Thousand only) and it will be the corpus of fixed property of the Trust, and it shall not be disposed of or subjected to any kind of charge for the purpose of meeting the expenses or for carrying out the objects of the Trust or for any other purpose unless otherwise resolved unanimously by the Board of Trustees.
- 5. That the Trustees shall stand and be possessed of the said Trust fund upon Trust to receive the interest, dividends and other income thereof and thereabout and in the first place to reimburse themselves or pay and discharge all the costs, charges and expenses incurred in or about or incidental to the administration or execution of the Trusts or powers of these presents and also all outgoings, taxes, rates, assessments, dues, duties, levies imposts and other taxes payable in respect thereof and the costs of meeting ordinary repairs to any immovable property if for the time being subject to the Trusts of these presents and subject thereto upon Trust to apply the residue of the said interest, dividend and other income (therein after called the 'said Income') and the corpus of the Trust fund/or public charitable purpose namely relief of the poor, spread of education, medical relief and any other object of general public utility provided that the benefits will be given to all irrespective of caste, creed, co lour or religion.

6 Provided that the said income of the Trust shall be applied only towards public charitable purpose only.

## 7. OBJECTS OF THE TRUST

Without prejudice to the generality of the foregoing objects or purposes, the Trustees shall each year apply the residue of the said income for the following objects and purposes at the discretion of the Trustees which they think proper.

a) To run Computer Class, Nursery School, Primary School, High School, College of every branch (Art, Science, Commerce) post graduation courses, B.Ed., D.Ed, M.Ed, Women's College, Law College, Pharmacy College, engineering college to run Computer Courses & Library, Technical (engineering, Architecture, Medical, MBA). To join and or affiliate with any other organization and or institution in similar nature through out India.

b) To run the school college

d) To help poor widows & help them to become economically independent by teaching them teaching courses, courses etc.

8) To keep swipar by and to pay salary 👀.

To award scholarships and prizes to students, to hold competition, seminars, workshops. To organize, conduct, sponsor and support training programme, conferences, exhibitions, exchange visits, study forms etc. in India for professional growth and exchange both for in house staff of the Trust and for development work for the organizations, who engage in activities in which the Trust may involved. The Area of Operation Society/Trust's activities shall be at Bhayandar, Vasai Road, Nallasopara as well as Thane District, Bombay City and Whole of Maharashtra State as well as all over India.

To start publication of Magazines, periodicals etc for promotion of education, health and awareness.

3. MEMBERSHIP

) Eligibility:-



Membership of the Trust shall be open to any adult Person.

A person intending to be a member of the Trust shall apply in Prescribed form duly filled in and signed along with application fees, if any.

The Trustees shall have absolute right to either accept or reject the application for membership without assigning any reason.

Termination of Membership:-

A person shall cease to be a member of the Trust.

On tendering his resignation in writing to Trustees of Trust; or

On his death; or

If he is found to be of unsound mind; or

If he has declared to be an adjudicate insolvent or is an UN discharged insolvent; or

If he has been convicted by a court or Tribunal of competent Jurisdiction of any

offence; or

If he has been convicted by a court or Tribunal of competent Jurisdiction of any offence; or

If his act or behavior is found ultra virus the rules, regulations or laws of the said Trust and upon his conduct his membership is terminated at a Managing Committee meeting of the Trust called for the purpose.

## 9. GENERAL BODY

Body formed by the membership of the Trust shall constitute the General Body. It shall hold General Body meeting once in a year within six months of the close of the each financial year to transact the following business:-

o adopt the accounts and audited balance sheet and income and expenditure accounts of the Trust prepared by the Secretary of the Trust.

To appoint Auditors to hold office until the next Annual General Meeting and to fix their remuneration.

To order to ensure proper conduct of affairs, management and administration of the Trust, the General Body Shall elect amongst its members any and such committees as may be necessary.

To admit members of the Trust who had applied for the membership.

To do all such other thing, acts, deeds etc. incidental or conductive to the attainment of the object of the Trust.

#### 10. MANAGEMENT & ADMINISTRATION

The management and administration of the Trust Properties and affairs thereof shall rest in the hands of the Trustee. The Trust Board shall exercise all such powers and do all such acts, deeds, matters and thing as they required be exercising or doing to manage and administer the affairs of the Trust Properties.

The Trust Board may from time to time delegate any of its powers to a committee which may be formed by it consisting of such of them as they may think fit. The Trust Board may from time to time revoke, dissolve and discharge any such committee or committees either wholly or in part and either as to person or proposes but every such committee so formed shall in exercise of the powers so delegated confirm to any regulations that may from time to time be framed by the Trust Board.

The Trust Board may also form committee or committees of any member or members belonging to any particular area or place for the purpose of carrying out or looking after the activities of the Trust in that particular area or place and every committee so formed shall carry out the directions that may be given to it from time to time by the Trust Board. The Trust Board shall have power to revoke, dissolve and discharge such committee either wholly or in part and either as to person or purposes as the Trust Board may deem fit.

First Trust Board shall consist of the Trustees nominated by the Settler and subscribers to the Trust Deed.

#### 11. MODE OF SUCCESSION

The number of Trustees of these presents shall not be less then three and more than sixteen. The said trustees of these presents shall act as trustees for life or until they resign or otherwise vacate their office or are removed as here in after contained. However, any of the said Trustees may at any time resign his office of the trustees by giving one months notice to his/her co- trustee and upon the expiry of such period, such trustee shall be deemed to have vacated the office.

#### 12. RIGHT, DUTIES, POWERS & LIABILITIES OF THE TRUSTEES

The Trustees will have full authority to buy and sell of immovable properties.

The Trustees have a right to use the funds of the Trust to maintain or repair the

properties of the Trust.

The Trustees shall keep and maintain proper books of account with respect to all sums of money received and expended on account of the Trust and matters in respect of which such receipt and expenditure take place and the liabilities and assets for the time being of the Trust. The financial year for the Trust shall be from April to March. The books of account shall be kept at the registered office of the Trust or at such others place or places as may from time to time be determined by the Trustees.

The Trustees shall be the custodians of the trust properties, whether movable or immovable and the same shall be invested, administered, disposed off or transferred by them in such manner as may be decided by them from time to time in accordance with these presents.

The Trustees can acquire buy or obtain on lease or otherwise any plot of land, building, flat, units or any immovable property.

The Trustees can accept any funds donations or gifts either unconditionally or with reasonable conditions and can also take loans with or without giving any security to achieve the objective of the Trust.

The Trustees, to achieve the object of the Trust can give donation, gifts, presents etc., can give and accept cash or any other item and can buy or sell movable or immovable property and can give such property on rental basis.

The Trustees can accept resignation of any Trustee and appoint any desirable person to fill up vacancy.

#### 13. MEETINGS

The quorum for the meeting shall be one-third (1/3) of the total strength of the members/Trustees. If the quorum is not present at the scheduled time of the meeting, the meeting shall stand adjourned for half an hour and adjourned meeting shall be held at same place irrespective of the quorum present and the decisions taken in such a meeting shall be binding on all the -members/Trustees. If within half an hour from the time appointed for holding a meeting, quorum is not present, the meeting if called by requisition of members/Trustees shall stand dissolved.

The Settler/President of the Trust shall be chair person to the meeting. In the absence of president the members/Trustees will elect amongst themselves a chairman and the person so appointed as the chairman will have all the powers, rights and authorities as a Chairman for that particular Meeting.

Any inadvertent omission to give notice or no receipt of notice by any member shall not invalidate the proceedings of the meeting.

No business shall be transacted at any meeting unless the requisite quorum of members/Trustees is present.

notice of the meeting shall specify the time and place of the meeting and notice of the meeting. An oral advice will also serve the purpose.

All decisions in the meeting shall be taken by simple majority and voting. In case of a tie of difference of opinion among the members/Trustees, chairman shall have casting vote and the matter shall be decided accordingly.

Any business other than those mentioned in the agenda will be carried out only after the permission of the Chairman.

## 14. TYPE OF MEETINGS

## a) Annual General Meeting:-

- i) The annual general meeting shall be held once in a year with in six months of the close of the financial year.

iii) The meeting of the members shall be held by giving at least twenty one (21) days notice in writing. The notice of the meeting shall be issued to all the members of the Trust by the Secretary and in his absence the same shall be issued to the President.

## b)Trust Board Meeting :-

The Trust Board shall hold their meeting at least once in three (3) months and four (4) in a year.

The meeting of the trust Board shall be held by giving at least seven (7) days notice in writing. The Notice of the meeting shall be issued to all the committee members of the Trust by the Secretary and in his absence the same shall be issued by the President. An oral advice will also serve the purpose.

#### 15. ACCOUNTING YEAR

The Accounting year of the Trust shall be from 1<sup>st</sup> April to 31<sup>st</sup> March every year.

#### 16. SOURCES OF INCOME

The sources of income of the Trust shall be contributions, donation and returns on investment in movable and immovable properties.

#### 17. OPERATION OF BANK ACCOUNT

The operation of the bank account of the Trust shall be in such banks and in such name (s) as may be decided by the Trust Board and shall be operated by at least Two (2) persons.

#### 18. AUDIT OF ACCOUNTS

The accounts of the Trust shall be audited annually by a Chartered Accountant or a firm of Chartered Accountants appointed by the general Body.

## 19. CHANGES IN CONSTITUTIONS, NAME AND OBJECTS

Any change in the constitutions, name and objects shall be done following procedure:-

The draft for change in Trust Shall be given duly signed by at least 2/3 members or if the Trust Board feels the necessity of making change in the Constitutions, name and objects then it shall give one months notice in advance to the trustees. The trust Board shall also advertise the draft with instructions in a pamphlet to be forwarded to the members. After one month but within 2 months of date on which such draft is published a general Meeting of the members shall be held for making discussions and decisions on such changes in constitutions, name and objects after its approval in a manner stated above it shall be binding and shall form the part of such trust as per the B.P.T. Act, 1950.

## 20. DISSOLUTION OF THE TRUST

- a) Any number not less than 2/3<sup>rd</sup> of the members present in person at any meeting convened for the purpose may determine that the Trust shall be dissolved, whether forthwith as per the B. P. T. Act., 1950. If upon the dissolution of the Trust there shall remain after the satisfaction of its debts and liabilities, any property whatsoever it shall be given to some other trusts working for the same objects.
- b.) The members of the Trust will have no right over the property of the Trust on its dissolution.
- 21. The Trust hereby established shall be irrevocable.
