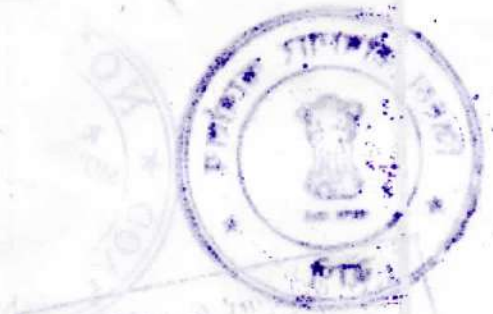


- That the school is run as a community service and not as a business and that commercialization does not take place in the school in any shape whatsoever.
